PLAINTIFFS' RESPONSE TO DEFENDANTS' MOTION TO DISMISS

NOW COME the Plaintiffs, AMP GLOBAL CLEARING, LLC, AMP FUTURES, and DANIEL CULP, by and through their attorneys, WARNER LAW OFFICE and respond to the Defendants, BIG MIKE TRADING, LLC and MICHAEL BOULTER, Motion to Dismiss as follows:

INTRODUCTION

The Plaintiffs in this matter have filed a ten Count Complaint against the Defendants in this matter alleging violations of the Illinois Deceptive Practices Act, Defamation and Commercial Disparagement.

SECTION 2-615 and SECTION 2-619 MOTIONS TO DISMISS

A Section 2-615 motion is appropriate only if the motion may be determined <u>solely</u> from the face of the pleadings. A Section 2-615 motion is inappropriate if matters not apparent on the face of

the pleadings must be considered to decide the motion; that is, if the defect challenged lies in the underlying facts rather than in the pleadings. See, e.g., Dunn v. Baltimore & Ohio R. Co., 162 III.App.3d 97, 515 N.E.2d 1027 (4th Dist. 1987). A Section 2-615 motion admits all well-plead facts, and all reasonable inferences drawn from those facts, and attacks only the complaint's legal sufficiency. Kendall v. Kendall, 71 III.2d 374, 375, 375 N.E.2d 1280 (1978); Curtis v. Cook County, 109 III.App.3d 400, 440 N.E.2d 942 (1st Dist. 1982), aff'd in part, rev'd in part on other grounds, 98 III.2d 158, 456 N.E.2d 116 (1983).

In determining whether a complaint states a cause of action, courts liberally construe the complaint so as to do substantial justice between the parties and to determine the controversy according to the substantive rights of the parties. Borushek v. Kincaid, 78 Ill.App.3d 295, 397 N.E.2d 172 (1st Dist. 1979); Ill.Rev.Stat.1991 ch. 110 §§ 1-106, 2-603(c). The court should interpret facts alleged in a complaint in a light most favorable to plaintiff, and the complaint should not be dismissed unless the pleading discloses no set of facts, if proved, under which plaintiff could recover. Davis v. Keystone Printing Services, Inc., 111 Ill.App.3d 427, 444 N.E.2d 253 (2d Dist. 1982); Cain v. American National Bank & Trust Co. of Chicago, 26 Ill.App.3d 574, 325 N.E.2d 799 (1st Dist. 1975); Callaizakais v. Astor Development Co., 4 Ill.App.3d 163, 280 N.E.2d 512 (1st Dist. 1972). A pleading must show only the possibility of recovery, not an absolute certainty, and it should not be dismissed unless it appears that the pleader in no event would be permitted to recover. Neuman v. City of Chicago, 110 Ill.App.3d 907, 443 N.E.2d 626 (1st Dist. 1982).

A motion to dismiss under 735 ILCS 5/2-619 admits all facts well-pleaded, and the court must accept as true not only those facts but all reasonable inferences therefrom. In re Estate of Krevchena, 244 Ill.App.3d 160, 165, 614 N.E.2d 74, 78 (1st Dist. 1993); Suslick v. Rothchild Securities Corp., 164 Ill.App.3d 589, 517 N.E.2d 600 (1st Dist. 1987).

Where plaintiff has alleged the facts supporting his claim with as much precision as might reasonably be expected, facts rather than conclusions have been alleged. People ex rel. Scott v. College Hills Corp., 91 Ill.2d 138, 435 N.E.2d 463 (1982); John Burns Const. Co. v. City of Chicago, 234 Ill.App.3d 1027, 601 N.E.2d 1024 (1st Dist. 1992). Plaintiff is not required to allege facts with precision where the necessary information is within the defendant's knowledge and plaintiff has not had the benefit of discovery; plaintiff must be given the opportunity to have the benefit of discovery and further develop the facts in this case. John Burns Construction Co. v. City of Chicago, 234 Ill.App.3d 1027, 601 N.E.2d 1024 (1st Dist. 1992); Sherman v. Field Clinic, 74 Ill.App.3d 21, 392 N.E.2d 154 (1st Dist. 1979) (to require plaintiffs, without benefit of discovery, to include in their complaint sufficient factual detail to permit a determination on these questions from the fact of the complaint is both unrealistic and unnecessary); see generally 3 R. MICHAEL, ILLINOIS PRACTICE § 23.4 at 310 (1989).

A motion, even one titled a motion to dismiss, is in reality two motions, a motion to strike the pleading and a motion to dismiss the case, and should be considered in two stages. The first stage consists of the determination of whether the pleading should be stricken. If it is stricken, the court should then consider whether leave to amend should be allowed or whether the action should be dismissed. 3 R. MICHAEL, ILLINOIS PRACTICE § 27.2 at 493 (1989) (citation omitted). Even when plaintiff does not file a formal written request for leave to further amend, it has been held to be an abuse of discretion to deny plaintiff leave to further amend the complaint when plaintiff demonstrates at the hearing on the motion to dismiss that the additional amended complaint would have contained allegations materially different from those of the prior filed complaints and which cure the defect complained of. Deasey v. City of Chicago, 412 Ill. 151, 105 N.E.2d 727 (1952); Chestnut v. Adeli, 131 Ill.App.3d 24, 475 N.E.2d 260 (4th Dist. 1985).

Communications Decency Act

The Defendants base their motion to dismiss solely on the immunity provided in 47 U.S.C. Sec 230. The Defendants contend this immunity expressly and expansively preempts any state and local law inconsistent with Section 230. The Defendant throughout their motion continually cites Section 230 but do not cite the case law which interprets the statute. The Defendants twist the statute into giving them an absolute immunity; which is clearly not recognized under the case law. The case law clearly states that Communications Decency Act (CDA) reflects no congressional intent, expressed or implied, to preempt all state law causes of action concerning interactive computer services; CDA provision reflect Congress' clear and unambiguous intent to retain state law remedies except in event of conflict between those remedies and CDA. Zern v. America Online, Inc., 958 F.Supp. 1124, affirmed 129 F.3d 327, certiorari denied 118 S.Ct. 2341, 524 U.S. 937. In addition immunity afforded by the Communications Decency Act is not absolute and may be forfeited if the site owners invites the postings of illegal materials or makes actionable postings. Jones v. Dirty World Entertainment Recordings, LLC, E.D.Ky. 2013, 2013 WL 4068780. Clearly the immunity claimed by the Defendant here must be examined in light of the cases defining the immunity. Nothing in this Section 230 shall be construed to prevent any State from enforcing any State law that is consistent with this section.

First and foremost the Communications Decency Act offers no protection to a service provider for publishing tortious content created by the provider itself. *Doe v. Friendfinder Network, Inc., 540 F.Supp 288, reconsideration denied 2008 WL 2001745.* Where the tortious information is published by BIG MIKE TRADING, LLC or MICHAEL BOULTER the information is not

protected by Section 230. Section 230 only grants immunity to a computer service provider if defined as a "publisher"; if the service is defined as an "information content provider" no immunity is provided. *Ben Ezra, Weinstein, and Company, Inc., 206 F.3d 980, certiorari denied 121 S.Ct. 69, 531 U.S. 937.* Nothing tortious published by BIG MIKE TRADING, LLC or MICHAEL BOULTER is immune from liability.

Further where a website operator invited, encouraged or adopted tortious postings the website operator is not entitled to immunity pursuant to the Communications Decency Act. If the operator made comments about defamatory posts or encouraged further defamatory posts no immunity attaches to the site provider. *Jones v. Dirty World Entertainment Recordings, LLC, E.D.Ky. 2013, 2013 WL 4068780.* It is clear that the case law does not allow a website operator to participate in the tortious activity and then claim immunity under Section 230. When the postings by BIG MIKE TRADING, LLC or MICHAEL BOULTER are reviewed they should not be granted immunity given their participation in the actionable postings.

The Courts have held that whether the service provider developed or materially contributed to the content of the posting requires determinations of issues of fact and should not be resolved on a motion to dismiss under the Communications Decency Act. CYBERsitter, LLC v. Google Inc., 905 F.Supp.2d 1080. (2012) Clearly, in Illinois all questions of fact must be submitted to the jury for determination. Here if BIG MIKE TRADING, LLC or MICHAEL BOULTER participated at all or invited participation the tortious post then their request for immunity should fall on deaf ears.

STATEMENTS OF FACTS AND ARGUMENT

Big Mike's Trading "Forum was established to help traders by openly sharing indicators, strategies, trading journals and discussing psychology of trading". MICHAEL BOULTER is the owner and a frequent poster on BIG MIKE TRADING, LLC. (BMT) As a frequent poster MICHAEL BOULTER is not a "publisher" under the Act but instead he is "information content provider" and as an "information content provider" is not entitled to immunity under the Communications Decency Act. In addition to posting on the forum MICHAEL BOULTER also makes all the decisions as to who can post on the forum and who will be barred from posting on the forum. MICHAEL BOULTER is also the sole decider as to what content is appropriate for posting on the forum and what content is inappropriate on the forum. If MICHAEL BOULTER determines that a poster has not followed the posting rules as to content or the person has made a personal attack on another poster it is MICHAEL BOULTER who, in his sole discretion, determines if the poster is barred from making additional postings. There are two ways of controlling content on a site one by controlling what is posted and the second by controlling what is not allowed to be posted. MICHAEL BOULTER does both. By definition MICHAEL BOULTER is not only a "publisher" as to the information on Big Mike's Trading Forum, he is the sole arbitrator and the gatekeeper as to the content of the forum. This site is clearly not just a site open to the public such as google. MICHAEL BOULTER owns the site, he posts on the site, he moderates information on the site, he determines who can post on the site and he solicits people to post on topics he wants on his site. This site is controlled and directed by MICHAEL BOULTER.

The Plaintiff, Dan Culp, is the owner of AMP GLOBAL CLEARING, LLC. and AMP

FUTURES. (AMP/CULP) In the past, Culp was a poster on Big Mike's Trading Forum. As a poster he was allowed to defend his company against inaccurate information on the site. On September 7, 2011 MICHAEL BOULTER banned Culp/AMP from posting in the forum. (Exhibit 1) After Culp was banned by MICHAEL BOULTER, Culp had a major BMT third party platform sponsor contact MICHAEL BOULTER to try to work out their problems. MICHAEL BOULTER's response to the third party sponsor was I will pass on having a phone call with Culp and asked the third party sponsor to not step between MICHAEL BOULTER and Culp. After which MICHAEL BOULTER posted on BTM that he tried to work out the matters with Culp but instead Culp filed this lawsuit. It should be noted that not until after this lawsuit was filed did MICHAEL BOULTER reach out to Culp. Only when he was faced with the prospect of a lawsuit did MICHAEL BOULTER attempt to contact Culp. Clearly the postings by MICHAEL BOULTER are false.

In addition to not reaching out to Culp until after the lawsuit was filed, on August 13, 2013 MICHAEL BOULTER solicited posters to contact him if AMP Trading/AMP Global was threatening to close the posters accounts for posting on BMT forum. In this post MICHAEL BOULTER refers to himself as a moderator on the forum again showing his control over forum content. MICHAEL BOULTER posted "It has come to my attention from multiple users that AMP Trading/AMP Global is threatening to close trading accounts against users who share their experiences about AMP Trading on BMT. If this has happened to you, please contact me ASAP". (Exhibit 2) In another occasion MICHAEL BOULTER posts "Careful about making complaints about AMP. They may threaten you to remove it.... I have fought AMP with attorneys to preserve the right for people to post their experiences about AMP on BMT freely. Just be prepared to switch brokers if they were to decide to close your account". (Exhibit 3) It

should be noted that AMP has never threatened anyone who was posting on BMT that it would close their trading account because of their postings on BMT nor has AMP ever threatened to file a lawsuit against anyone who posted opinions against AMP on BMT. These statements are just simply not true. AMPS sole purpose of wanting correct information to be reported on this site is because they knows the traders on this site react and trade to what they think is accurately reported information. When the information is inaccurate or twisted by MICHAEL BOULTER the independent traders are potentially hurt. MICHAEL BOULTER has made these false and defamatory postings for the sole reason of affecting AMP's business and refuses to let AMP respond.

In addition to the above false and slanderous statements posted MICHAEL BOULTER also made other postings that are not true. MICHAEL BOULTER has posted that he is in litigation with AMP in order to defend his posters rights on BMT. (Exhibit 3) Prior to the present claim, AMP had not been involved in any litigation against MICHAEL BOULTER nor BMT. This lie is for self-promotion of MICHAEL BOULTER to indicate to his posters that AMP is litigious and will sue posters while MICHAEL BOULTER will protect the posters right to post. Neither proposition is true. Clearly when MICHAEL BOULTER himself is posting untrue statements his statements and the corresponding information posted because of his statements on the site cannot be considered immune.

Along with his untrue postings, MICHAEL BOULTER refuses to allow AMP to sponsor on the site. MICHAEL BOULTER does allow other competitors of AMP to pay him to sponsor on the site. Not only does MICHAEL BOULTER not allow AMP to sponsor on the site he will not allow anyone who works with AMP sponsor on the site. (Exhibit 4) Prior to this litigation Allison Buckley, who worked at Global Futures, was attempting to advertise on BTM and in

response to her conversation with MICHAEL BOULTER she emailed him and informed him what clearing houses she worked with. One of her six clearing houses she listed she worked with was AMP. MICHAEL BOULTER states in his reply email to Allison Buckley "I do have serious issues with AMP. I am not interested in starting a new business relationship with anyone that does business with AMP". MICHAEL BOULTER then refuses to do business with Buckley, clearly showing his own personal biases against AMP.

Lastly MICHAEL BOULTER has banned AMP and AMP's employees from posting on the forum. (Exhibit 1) On numerous occasions AMP has contacted MICHAEL BOULTER and informed him that the information on the forum was incorrect and needed to be changed to provide correct information to the individual posters on the forum. AMP was informed that it was banned from posting on the forum and that the forum would not allow them to post any corrections or rebuttals in answer to the postings. By banning AMP from posting MICHAEL BOULTER is controlling the content of the postings by not allowing rebuttal or corrections.

MICHAEL BOULTER is the gate keeper to what information is allowed on the forum and what information or posters are not allowed on the forum. Clearly by not letting AMP respond to inaccurate information on the postings MICHAEL BOULTER is controlling the content of the postings on the forum. The Communications Decency Act was not meant to shield this type of behavior.

Not only does MICHAEL BOULTER control the information that is posted on the site he also participates and solicits posters to provide negative information against AMP. On January 7, 2014 MICHAEL BOULTER allowed James Stone to post on BMT a clearly defamatory posting against AMP/Culp even though the subject matter of the posting had nothing to do with the sites stated goals "to help traders by openly sharing indicators, strategies, trading journals and

discussing psychology of trading".

James Stone was an independent contractor who wrote computer code for AMP. Stone was fired because of performance reasons. When Stone was released all of his invoices to that point in time were paid. Two months after Stone was released he sent AMP a one line invoice for sixty-five thousand dollars. (Exhibit 5) AMP refused to pay this invoice. MICHAEL BOULTER allowed the following defamatory post on the site he controls even though the posting has nothing to do with the forum's stated purpose.

The Posting titled "The Almighty Unethical AMP Trading"

Let me tell you a story of how AMP Trading and more specifically the owner Dan Culp conducts business. They will lie to your face, tell you what you want to hear and fail to deliver on any promises made. If you're looking to trade with an ethical company look someplace else, AMP Trading will surely take your money and promise the world they can't deliver.

Not only will they take your money and run, they can't pay their bills. They take advantage of outside vendors, get work then refuse to pay. The staff gets treated poorly and the only person in the company who gets compensation for their daily jobs (above slave labor wages) is the owner Dan Culp.

Why would you trust me? I worked there for several years until I just couldn't take the toddler mentality of the owner who when he doesn't get what he wants throws temper tantrums most two year old BABIES would be proud of. Ask around many people have seen this.

Dan spends more time trying to defeat people that are stating honest facts than he does trying to build an ethical business. Who would ever want to do business with a liar and cheat?

If you are currently doing business with AMP consider your options and move your money before he takes it and runs, he doesn't care about you, he cares about making sure he is liked and that he is known as a big spender on frivolous parties.

Trust me AMP is falling to their knees, take your business to someone who would actually appreciate having it.

Don't be the one getting punched by AMP, take a stand and tell me what you have experienced. (Exhibit 6)

Clearly this posting has nothing to do with the concepts of trading and is only a personal attack on AMP/Culp. For MICHAEL BOULTER, the forum moderator, to allow this personal attack and this defamatory posting on the site when the content clearly violates the sites stated rules is not proper and not protected by any immunity.

In response to the inappropriate posting Culp emailed MICHAEL BOULTER and requested that the post be removed. In Mr. Culp's email he stated:

From: AMP

Sent: Tuesday, January 7, 2014 9:49 AM

To: 'mike@bigmiketrading.com

Cc: 'Deux, Raymond

Subject: Sorry your forum being used again: Rogue developer slandering AMP

on BMT

This is an owner of a development company we used, that went crazy. Actually told me that he would not work anymore unless I went to church with him on Sundays.

Thank you

Dan

(Exhibit 7)

MICHAEL BOULTER, instead of removing the slanderous posting from the site, sent the email he received from Culp to James Stone, the poster. At 11:18 AM, one hour and twenty minutes after Culp sent MICHAEL BOULTER the email, Culp received a text message from James Stone stating: "Went crazy' huh? I bet I can cost you more than if you were to settle". (Exhibit 8) Clearly, Stone is quoting from the email Culp sent to MICHAEL BOULTER one hour and twenty minutes earlier. When MICHAEL BOULTER forwarded the email to James Stone he is no longer acting as a "publisher" as defined by Communications Decency Act but instead is in the throes of creating the next post. James Stone continued posting slanderous remarks on BMT. On January 7, 2014 he posted at 11:23 AM, 11:41 AM and 1:15 PM. The additional posts state

AMP has no money; your money is not safe with AMP and AMP going out of business. At no point in time did MICHAEL BOULTER prevent the slanderous statements from being posted even though the postings were in violation of MICHAEL BOULTER's own rules and were in no way related to the stated purpose of the forum. Nor did MICHAEL BOULTER allow AMP to defend itself even though AMP requested to write a post.

In the Defendants' Motion to Dismiss and the attached affidavit, they set forth a defense that MICHAEL BOULTER did not edit or change the information posted by James Stone. Their defense is that they are only a publisher of the provided information. What the affidavit does not address is the actions of MICHAEL BOULTER in sending the private email he received from Culp to Stone. This action solicited more postings from Stone. Nor does the Motion to Dismiss address the false and deflamatory postings made by MICHAEL BOULTER. In paragraph 24, adopted in each count, the Plaintiffs clearly state that MICHAEL BOULTER himself posted untrue and defamatory statements about the Plaintiffs. Lastly the Defendant's Motion to Dismiss does not address the issue that MICHAEL BOULTER prevented the Plaintiffs from responding or correcting the inaccurate information posted thereby controlling the content presented in the forum. Based on the allegations in the complaint, which must be taken as true, the Defendants' Motion to Dismiss should be denied.

CONCLUSION

To be a service provider and be protected by the immunity set forth in the

Communications Decency Act the provider must act as a neutral and not control the content and
who is allowed to post on the site. Here MICHAEL BOULTER controlled what was allowed to be

posted on the site, who was allowed to post on the site, who was not allowed to post on the site and who was allowed to rebut the postings on the site. He controlled the content of the post and if he did not like the content of the post he would remove the post. MICHAEL BOULTER by definition is not a service provider who is neutral but an active participant who controls the direction and content of the postings.

The Courts have held that what role the administrator of the site plays in the distribution of the information on the site is a question of fact and should not be decided on a Motion to Dismiss. Here the Defendants request this Court to rule as a matter of law that the actions in controlling the data posted on BMT by Michael Boulter were not enough to raise a question of fact as to his role in the liable information presented on the site. This position is clearly in contrast to the existing law and this Court should deny the Defendants' Motion to Dismiss. This Court would have to rule that as a matter of law even though MICHAEL BOULTER has complete control over the content of the site and the fact that he exercises that control over the content of the site, he is immune from liability for the slanderous and defamatory remarks on the site. This type of ruling would be against all existing law.

I am sorry to have to report that AMP Futures has been banned from BMT.


After numerous private messages to Dan containing warnings about self-promotion in his posts, as well as rude behavior and most recently his posts bashing another broker, he has been banned.



Let me alleviate your suspicions by starting from the beginning.

I am a software developer and I met Dan/Amp Futures about four years ago while working at gate39media. We were hired to build his online accounts portal (which was at the time actually Dorman's account portal) for his transition into becoming an FCM. AMP Global Clearing was launched in October and I left gate39media that December to go work at a different consulting firm. While I was working at Clarity consulting I decided to start my own business and let Dan know. In August of 2011 I started my own company and began working with AMP Global in October to rebuild his online accounts portal, Dan agreed to the contract of 100 hours per month at a rate of \$100 per hour or 10k per month. The project was to last three months and be ready to go online Jan 1 of 2012. On Christmas night he called to yell at me for not having it online, when his IT company dld not have the server ready for me to launch. Jan 3rd we met to talk status and he steps through the entire process changing something in every step which delayed the launch another three months. Then he added this feature and that feature which continued to delay the launch. Much of the development time was spent reworking the process' that Dan changed on a monthly basis (my time, his dime). During this time I would receive phone calls/text messages from 3am to 11pm almost daily, there were never any boundaries that he would not cross. We finally went live with the new online accounts portal on December 1 2012, he called gate39media and told them they were fired. Giving them less than two hours notice before they got replaced.

In March of 2013, I went to Tanzania, Africa on a mission trip and accepted Jesus as my Lord and Savior, which led me to reevaluate many facets of my life and helped me gain an understanding of being 'satisfied' in my life and my work. I love writing software but I hated not knowing when Dan was going to pay me. I was tired of working well over 100 hours per month and giving him that labor for free. My monthly hour averages for AMP are close to 150 hours giving him almost \$5000 in labor per month for free. I'm a one man development shop trying to support over 10,000 accounts and make continual progress on new development. Any one in development knows this is a project for a team of three to five people. However Dan's thoughts are that I should work 24/7 solely for his company and not get paid for it. Had he kept true to our contract I would have been able to bring more people on board. He consistently told me he could be consistent, but the only consistency in Dan/AMP is inconsistency.

In November of 2013 I went on another mission trip to Oklahoma to help rebuild a Church for TeenChallenge. While down there I decided that working for AMP was making my life miserable and the added stress of never knowing what months I was going to get paid made it difficult for my business to ever get off the ground. During this time my church was holding a series called 'Satisfied' (media . willowcreek . org). I suggest everyone watch the series, because I don't know too many people who are truly satisfied with every aspect of their lives. When I came back fro OK, I invited Dan to the last message of the series because I was incredibly unsatisfied with they way things were going, while consulting for AMP, and I was tired of living my life in the DOC area (Dangerously Over Challenged). In fact I told Dan to show up or I would not continue doing business with him. He did not show up and we are not in business together; he states that I went crazy. Well in one way he is correct, I was losing my mind building HIS business without any real plans. After all, he changes his mind almost weekly which would require me to rewrite several thousand lines of code; and not get paid. I was tired of it, did I actually go crazy, NO. I asked the man to hold up his end of the bargain, be consistent and to gain an understanding of what I was thinking and where I was coming from.

I stand by my decision to bring God into my business and to invite Dan to church, God knows he needs it. I would surely do it again and ensure that not only am I satisfied in my work but also to ensure that those whom work for me and the people I do business with are truly satisfied in there lives. Dan has a whole in his soul that he his trying to fill with expensive parties, money and a disgusting attitude toward whats fair, I he isn't winning he thinks he is losing. With his attitude he is only losing and I truly hope that he realizes it before he loses everything. Much of his staff is looking for new jobs because they are tired of his attitude, his lock of boundaries and his treatment of people who have his best interest in mind. His only interest is his wallet, anything else... and well he just doesn't care. Sorry Dan life is too short to deal with the small minded mentality that you are the only thing that matters, you're not.

I can honestly say that I am satisfied knowing that Dan is reading this and not commenting... whats wrong Dan? Can't defeat this truth.


