Wyckoff via the Action Sequence

Effective investing and trading requires bedrock of sound principles which employ a well studied and researched investment methodology, fosters a balanced mental outlook and employees proper money management and risk control technique. The Wyckoff Method is a sound, time-tested and extremely practical philosophy for employing a strategy and judgmental methodology based on technical analysis in the global financial markets. The principle and the procedures of Wyckoff Method emphasized in the class will be the Law of cause and effect and the application of all point and figure chart. The Wyckoff relationships and the Law are revealed by vertical line charts and figure charts. Studies of bar charts student learn how to determine trends, dissect trading ranges, pinpoint turning points and locate when a market is displaying the readiness to move. The student uses the figure chart to determine price objective. In the course the instructor will guide you with the Wyckoff Method via the Action Sequence, a participative, dynamic and productive learning process. The instructors inspire to make the Wyckoff Method as inseparable part of how you conduct your trading and investments operations in the world's financial markets.

Nature of Wyckoff II

Wyckoff II, a continuation of Wyckoff I, places emphasis upon the laws of cause and effect. The Focus is upon the construction, interpretation and use of POINT-AND-FIGURE CHART.
